Terms and Conditions

Entry is open to UK residents aged over four. The winners may need to be able to provide proof of identity and age.

Email up to six photographs to ourtwocities@nickieaiken.org.uk along with your name, address and age category. You can also tag [@TwoCitiesNickie](#) on Facebook, Instagram or X (formerly Twitter) along with [#OurTwoCities](#).

There are two age categories for the competition, these are;

17 and under

18+

Parents, carers and legal guardians can submit on behalf of their children.

Pictures taken on any smartphone, tablet or camera are eligible.

No purchase is necessary for participation in this competition.

Up to six entries per person are permitted.

Entrants must comply with the rules of their chosen social media platforms if posting online.

The competition begins at 9 am on Monday 8 April 2024 and runs until 23:59 on Monday, 1 July 2024. Entries must be submitted and received no later than 23:59 on Monday, 1 July 2024 to be eligible for the competition judging. All competition entries received after 23:59 on Monday, 1 July 2024 will not be considered. The Promoter will not accept responsibility for delayed entries, regardless of cause. Proof of transmission will not be accepted as proof of receipt.

All those on the shortlist will be contacted.

Awards Ceremony

Winners and runners-up will be invited to a special awards ceremony in central London later in 2024.

By entering the competition, you grant the Promoter a non-exclusive, irrevocable licence to reproduce, enlarge, publish or exhibit, on any media, the images for any purpose directly connected with the competition. This may include, but is not limited to: inclusion in a book of winning and commended images; display at exhibitions; display on a web browser for judging purposes; on the Promoters website and on the websites of sponsors and supporters; on social media used by the Promoter, its sponsors and supporters; for use in releases to be distributed to national, regional & specialist press and other media giving information about or promoting the competition.

Winners will be notified via email after the closing date.

The Promoter of the competition is Nickie Aiken MP. The judging panel's decision is final and binding in all matters and no correspondence or discussion will be entered into.

The Promoter reserves the right to withdraw the awards ceremony. No alternative awards ceremony will be given.

they have the permission of anyone pictured in the image (or, where the image shows any persons under 18, the consent of their parent/guardian) for the usage rights required by the Promoter and will indemnify the Promoter against any claims made by any third parties in respect of such infringement

Submission of entries to the Photography Competition is deemed as acceptance of these terms and conditions. The promoter reserves the right to refuse the awards ceremony to anyone found to be in breach of these terms and conditions.

By entering the competition, you agree that any personal information provided by you may be held and used by the Promoter, its agents and suppliers to administer the competition.
